

EMERGENCY OVERVIEW

This product is a naturally occurring mineral which contains a small amount of crystalline silica in the form of quartz. Prolonged or repeated inhalation of crystalline silica over an extended period of time may result in lung damage and may cause lung cancer. The risk of cancer is dependent on the duration and level of exposure.

Potential Health Effects:

Eye: Contact may cause mechanical irritation with redness, tearing and pain.

Skin: May cause drying of the skin

Inhalation: Inhalation of high concentrations of dust may cause mucous membrane and respiratory irritation.

Ingestion: Swallowing large amounts may cause gastrointestinal irritation.

Chronic Hazards: Prolonged overexposure to dust may cause lung damage. This product contains a small amount of crystalline silica. This product contains crystalline silica.
